BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-479re: PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE BOHOL CIVIL SOCIETY ORGANIZATION'S WEEK: CSO TEAM BUILDING AND FELLOWSHIP with an ABC of P180,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL BEE FARM</u> <u>RESORT AND FRANCHISING CORPORATION</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL BEE FARM RESORT AND FRANCHISING CORPORATION</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>BOHOL BEE FARM RESORT AND FRANCHISING CORPORATION</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- To recommend award to <u>BOHOL BEE FARM RESORT AND FRANCHISING CORPORATION</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P180,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
