BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>GOVERNOR'S OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-480 re: <u>PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE BOHOL CIVIL SOCIETY ORGANIZATION'S WEEK: CSO SUMMIT</u> with an ABC of <u>P150,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PANDA TEA GARDEN SUITES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>PANDA TEA GARDEN SUITES</u> has been found to be <u>ELIGIBLE</u> and its bid, <u>RESPONSIVE</u>;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare PANDA TEA GARDEN SUITES as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the CATERING SERVICES under Negotiated Canvass No. 2022-467;
- To recommend award to <u>PANDA TEA GARDEN SUITES</u> for the Catering and Accommodation Services of the aforementioned request in the amount of <u>P144,596.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
