WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-484 re: PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE GENDER AND DEVELOPMENT PLANNING WORKSHOP with an ABC of P292,250.00;
