BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **GOVERNOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-484** re: **PROCUREMENT OF MEALS, SNACKS AND USE OF FACILITY FOR THE GENDER AND DEVELOPMENT PLANNING WORKSHOP** with an ABC of **₱292,250.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BELLE SOUTH PACIFIC PROPERTIES, INC./ THE BELLEVUE RESORT** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
