BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1142 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST - NUTRITION DIVISION in undertaking Procurement Request under PR No. 2022-0391 Procurement of Grocery Items for the use of Supplementary Feeding for for Preschool Children (6-59 months) and Pregnant Women, by the Office of the Provincial Agriculturist - Nutrition Division, with an ABC of ₱ 2,000,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, PRIM E CONSTRUCTION SUPPLIES TRADING has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the supplier with the **Lowest Calculated and Responsive Price Quotation** for the Delivery of Goods/Services under Negotiated Canvass No. 2022-0439 (2nd Failure); *except item nos. 2, 5 and 6;*
- b). To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING or delivery of goods/services under Negotiated Canvass No. 2022-0439 (2nd Failure) in the amount of ₱ 1,567,444.20; *except item nos. 2, 5 and 6;*
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
