WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2014 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST NUTRITION DIVISION in undertaking Procurement Request under PR No. 2022-0391 Procurement of of Grocery Items for the use of Supplementary Feeding for for Preschool Children (6-59 months) and Pregnant Women, by the Office of the Provincial Agriculturist Nutrition Division, with an ABC of P 2,000,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation:
