BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-448 re: PROCUREMENT OF PACKED MEAL FOR THE 18TH DAY CAMPAIGN TO END VIOLENCE AGAINST WOMEN (VAW) with an ABC of P87,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that JJ'S FOODLAND CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
