BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE PROVINCIAL VETERINARIAN** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. **2022-0677** re: Procurement of Disinfectant, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City, with an ABC of **P 1,553,440.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **LEZAR TRADING** offered the single price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **LEZAR TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **LEZAR TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
