BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH EMERGENCY CASES, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE PROVINCIAL VETERINARIAN** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0723 re: Procurement for Rental of K9 Dogs (services) for use at the Office of the Provincial Veterinarian, New Capitol Building, Tagbilaran City, with an ABC of P 975,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SPHINX K9 SECURITY SERVICE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **SPHINX K9 SECURITY SERVICE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **SPHINX K9 SECURITY SERVICE**, has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
