**BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the **PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-324** re: **PROCUREMENT OF MEALS AND SNACKS FOR THE FEASIBILITY STUDY/ PROJECT/ BUSINESS PLANNING FOR 2 PROPOSED REVENUE INITIATIVES/ ENTERPRISES** with an ABC of **₱ 75,000.00**;




