WHEREAS, the **PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0679 re; Purchase of various Office and Housekeeping Supplies with an ABC of P 77,230.00;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


