BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, NEW CAPITOL COMPOUND, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 - 0871** re: **Procurement of various spare parts, oil, and lubricants for service vehicle with plate no. SJC - 471 Isuzu/Crosswind** with an ABC of **P 69,432.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **JETS MARKETING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
