**WHEREAS**, the **PROVINCIAL ENGINEER'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-0267 A** re: **PROCUREMENT OF TECHNICAL CONSULTANT FOR THE STRUCTURAL ANALYSIS AND DESIGN SERVICES FOR PROJECTS OF BINOGAWAN, CALAPE 18M FLAT STAB BRIDGE, CABAYUGAN, CALAPE 18M RCDG BRIDGE, DESAMPARADOS, CALAPE 18M RCDG BRIDGE AND LABUON, CALAPE 18M RCDG BRIDGE ALONG DESAMPARADOS (CALAPE)-TABUAN (ANTEQUERA) FMR**, with an ABC of **₱ 785,000.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **QB ENGINEERING AND CONSTRUCTION**, offered the lowest price quotation among the contractors as reflected in the Abstract of Bids Proposals;

**WHEREAS**, pursuant to Section 53.7 (Highly Technical Consultant) of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of **QB ENGINEERING AND CONSTRUCTION**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **QB ENGINEERING AND CONSTRUCTION** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a). To declare **QB ENGINEERING AND CONSTRUCTION** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION-HIGHLY TECHNICAL CONSULTANT** for the **GOODS/SERVICES** under Negotiated Canvass No. **NC-2022-0100 A**;
- b). To recommend award to **QB ENGINEERING AND CONSTRUCTION**, for the goods/services of the aforementioned request in the amount of **₱ 780,000.00**;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
