BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, in the detailed evaluation of bids **PRIM E CONSTRUCTION SUPPLIES TRADING** was declared as the Lowest Calculated Bid as Read in the amount of P 642,673.00 and **JN'J PHARMA & MEDICAL SUPPLIES** was declared as the Lowest Calculated Bid as Read in the amount of P 645,559.00.

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **PRIM E CONSTRUCTION SUPPLIES TRADING** and **JN'J PHARMA & MEDICAL SUPPLIES**, met the required legal, technical and financial requirements for the said project.


WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **PRIM E CONSTRUCTION SUPPLIES TRADING** and **JN'J PHARMA MEDICAL SUPPLIES** the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project.

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



To declare **PRIM E CONSTRUCTION SUPPLIES TRADING** as the **LOWEST CALCULATED and RESPONSIVE BID** for item no. 1 in the amount of P 325,875.00 and **JN'J PHARMA & MEDICAL SUPPLIES** as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 2, 3, 4, 5, 6, 7, 8, 9, 10 & 11 in the amount of P 315,559.00 for the Procurement of Dental Supplies for use of the Dental Program Oral Health Implementation under Project Reference No. - PHO - 2022 – 106.
- b.) To recommend award to **PRIM E CONSTRUCTION SUPPLIES TRADING** in the contract amount of THREE HUNDRED TWENTY FIVE THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS ONLY (P 325,875.00) and **JN'J PHARMA & MEDICAL SUPPLIES** in the contract amount of THREE HUNDRED FIFTEEN THOUSAND FIVE HUNDRED FIFTY NINE PESOS ONLY (P 315,559.00).






