

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **BEROVAN MARKETING, INC.** the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;


**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a.) To declare **BEROVAN MARKETING, INC.** as the **SINGLE CALCULATED and RESPONSIVE BID** for items no. 1, 3, 6, 11, 12, 13, 14, 17, 18, 19 & 20 in the amount of **P 373,495.00** for the Procurement of **VARIOUS LABORATORY SUPPLIES** under Project Reference No.- **PHO - 2022 – 150**; while items no. 2, 4, 5, 7, 8, 9, 10, 15 & 16 having no quotation from the supplier are recommended rebidding.
- b.) To recommend award to **BEROVAN MARKETING, INC.** in the contract amount of **THREE HUNDRED SEVENTY THREE THOUSAND FOUR HUNDRED NINETY FIVE PESOS ONLY (P 373,495.00)**;






