BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-299 re: PROCUREMENT OF ACCOMMODATION AND CATERING SERVICES FOR THE RECORD REVIEW AND DATA VALIDATION AND RECONCILIATION IN DIFFERENT DRUGS AND UPDATES OF PISDR REPORTING SYSTEM AND CAPACITY TRAINING ON EPIDEMIOLOGY AND SURVEILLANCE with an ABC of ₱ 198,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
