WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1716 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL HEALTH OFFICE in undertaking Procurement Request under PR No. 2022-C-303 re: PROCUREMENT OF MEALS AND SNACKS FOR THE REFRESHER COURSE TRAINING ON ENVIRONMENTAL SANITATION PROGRAM TO PROVINCIAL AND MUNICIPAL SANITATION INSPECTORS with an ABC of ₱150,000.00;
