BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-469 re: PROCUREMENT OF MEALS AND SNACKS FOR THE MANAGING ATTITUDE AND TEAM BUILDING with an ABC of P86,625.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
