WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. - PHO – 2022 - 363 re: PROCUREMENT OF MASTER FOR RISO MACHINE AND TONER FOR RISO MACHINE & INEO with an ABC of P 100,900.00;
