BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, in the detailed evaluation of bids **RGZI MEDICAL AND LABORATORY SUPPLY** was declared as the Lowest Calculated Bid as Read in the amount of **P 754,765.75**, **SANJO MEDIPHARMA PHILS** has the 2nd Lowest Calculated Bid as Read in the amount of **P 873,304.50**, **PRIME LINK PHARMACEUTICAL** has the 3rd Lowest Calculated Bid as Read in the amount of **P 1,207,645.94**, **NDM PHARMA AND MEDICAL SUPPLIES** has the 4th Lowest Calculated Bid as Read in the amount of **P 1,210,164.80**, **BYRO PHARMA CORPORATION** has the 5th Lowest Calculated Bid as Read in the amount of **P 1,215,833.10**, **JN'J PHARMA & MEDICAL SUPPLIES** has the 6th Lowest Calculated Bid as Read in the amount of **P 1,295,036.00**, **J & M PHARMASHOPPE** has the 7th Lowest Calculated Bid as Read in the amount of **P 1,311,864.25** and **NUDRAGON CO.** has the 8th Lowest Calculated Bid as Read in the amount of **P 1,489,788.00**;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, PRIME LINK PHARMACEUTICAL, SANJO MEDIPHARMA PHILS, NUDRAGON CO, J&M PHARMASHOPPE, NDM PHARMA AND MEDICAL SUPPLIES, BYRO PHARMA CORPORATION, RGZI MEDICAL AND LABORATORY SUPPLY and JN'J PHARMA & MEDICAL SUPPLIES. met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by PRIME LINK PHARMACEUTICAL, SANJO MEDIPHARMA PHILS, NUDRAGON CO, J&M PHARMASHOPPE, NDM PHARMA AND MEDICAL SUPPLIES, BYRO PHARMA CORPORATION, RGZI MEDICAL AND LABORATORY SUPPLY and JN'J PHARMA & MEDICAL SUPPLIES. the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project per line item award;

WHEREAS, **NUDRAGON CO.** submitted a letter dated September 28, 2022, waiving its right to deliver for the awarded items for erroneous bid quotation. The TWG has recommended to award the said items to the next bidder who has the lowest in quotation (see attached letter for reference);


NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




