BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-453** re: PROCUREMENT OF MEALS AND SNACKS FOR THE QUARTERLY YEAR-END ASSESSMENT with an ABC of ₱55,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that JJ'S FOODLAND CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
