BAC RESOLUTION DECLARING SCRQ THROUGH NEGOTIATED MODE OF PAYMENT – EMERGENCY CASES AND RECOMMENDING AWARD

WHEREAS, the CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. PHO – 2022 – 367 re: Procurement of DRUG and MEDICINES with an ABC of P 234,300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that SAMOHEALTH PHARMA INC. offered the single price quotation as reflected in the Abstract of Bids Proposals;
