WHEREAS, upon the conduct of post qualification by the Technical Working Group, **BEROVAN MARKETING INC , PANAMED PHIL. INC , BYRO PHARMA CORPORATION** and **RUEN GONZAGA MARKETING & DEVELOPMENT, INC.** met the required legal, technical and financial requirements for the said project;
