**WHEREAS**, upon the conduct of post qualification by the Technical Working Group, **LABSOLUTION TECHNOLOGIES, INC**, **BYRO PHARMA CORPORATION** & **RUEN GONZAGA MARKETING AND DEVELOPMENT, INC.** met the required legal, technical and financial requirements for the said project;

**WHEREAS**, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **LABSOLUTION TECHNOLOGIES, INC**, **BYRO PHARMA CORPORATION** & **RUEN GONZAGA MARKETING AND DEVELOPMENT, INC.** the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



To declare **LABSOLUTION TECHNOLOGIES, INC** as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 4, 5, 6, 10, 13, 20, 21 & 22 in the amount of **P 1,105,500.00**, **BYRO PHARMA CORPORATION**, as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 1, 11, 14, 19, 25, 27, 28, 31, 33, 34, 36 & 38 in the amount of **P 305,600.00** & **RUEN GONZAGA MARKETING AND DEVELOPMENT, INC.** as the **LOWEST CALCULATED and RESPONSIVE BID** for items no. 2, 3, 7, 8, 9, 12, 18, 23, 24, 30, 37 & 39 in the amount of **P 201,073.60** for the procurement of **VARIOUS OFFICE SUPPLIES** under Project Reference No.- **PHO - 2022 – 077**; while items no. 15, 16, 17, 26, 29, 32 & 35 having no quotation from the supplier are recommended for rebidding.
