WHEREAS, in the detailed evaluation of bids <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC</u> was declared as the Lowest Calculated Bid as Read in the amount of P 1,358,500.00, <u>BYRO PHARMA CORPORATION</u> has the lowest Calculated Bid as Read in the amount of P 1,613,540.00 & RUEN GONZAGA MARKETING AND DEVELOPMENT, INC. was declared as the Lowest Calculated Bid as Read in the amount of P 606,758.60.

WHEREAS, upon the conduct of post qualification by the Technical Working Group, <u>LABSOLUTION</u> <u>TECHNOLOGIES, INC</u>, <u>BYRO PHARMA CORPORATION</u> & RUEN GONZAGA MARKETING AND DEVELOPMENT, INC. met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by <u>LABSOLUTION TECHNOLOGIES</u>, <u>INC</u>, <u>BYRO PHARMA CORPORATION</u> & RUEN GONZAGA MARKETING AND DEVELOPMENT, INC. the bidder declared as the LOWEST CALCULATED BID, successfully passed the Post Qualification process, thus the Committee now considered its bid as the LOWEST CALCULATED and RESPONSIVE BID for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a.) To declare LABSOLUTION TECHNOLOGIES, INC as the LOWEST CALCULATED and RESPONSIVE BID for items no. 4, 5, 6, 10, 13, 20, 21 & 22 in the amount of P 1,105,500.00, BYRO PHARMA CORPORATION, as the LOWEST CALCULATED and RESPONSIVE BID for items no. 1, 11, 14, 19, 25, 27, 28, 31, 33, 34, 36 & 38 in the amount of P 305,600.00 & RUEN GONZAGA MARKETING AND DEVELOPMENT, INC. as the LOWEST CALCULATED and RESPONSIVE BID for items no. 2, 3, 7, 8, 9, 12, 18, 23, 24, 30, 37 & 39 in the amount of P 201,073.60 for the procurement of VARIOUS OFFICE SUPPLIES under Project Reference No.- PHO 2022 077; while items no. 15, 16, 17, 26, 29, 32 & 35 having no quotation from the supplier are recommended for rebidding.
- b.) To recommend award to <u>LABSOLUTION TECHNOLOGIES, INC</u> in the contract amount of <u>ONE MILLION</u>
 ONE HUNDRED FIVE THOUSAND FIVE HUNDRED PESOS ONLY (P 1,105,500.00), <u>BYRO PHARMA</u>
 CORPORATION in the contract amount of <u>THREE HUNDRED FIVE THOUSAND SIX HUNDRED PESOS</u>

ONLY (P 305,600.00) & RUEN GONZAGA MARKETING AND DEVELOPMENT, INC. in the contract amount of TWO HUNDRED ONE THOUSAND SEVENTY THREE PESOS AND 60/100 (P 201,073.60).

c.) To recommend for the approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
