**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 238 re: PROCUREMENT OF LIQUIFIED PETROLEUM GAS 50KG with an ABC of P 106,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL OVERSEA COMMERCIAL offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL OVERSEA COMMERCIAL including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BOHOL OVERSEA COMMERCIAL has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BOHOL OVERSEA COMMERCIAL as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 106,600.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2022 - 147.
- b.) To recommend award to BOHOL OVERSEA COMMERCIAL in the amount of ONE HUNDRED SIX THOUSAND SIX HUNDRED PESOS ONLY (P 106,600.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 147;
- c.) To recommend for approval by-the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
