BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-441 re: PROCUREMENT OF CATERING SERVICES FOR THE SPMS ORIENTATION AND WORKSHOP FOR THE PGBH NEWLY HIRED EMPLOYEES INCLUDING PLANTILLA PERSONNEL with an ABC of ₱71,250.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
