BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the PROVINCIAL INFORMATION AND MEDIA OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. **2022-C-437** re: PROCUREMENT OF ACCOMMODATION, MEALS AND SNACKS FOR THE NEWSWRITING AND PHOTO JOURNALISM WORKSHOP with an ABC of **₱168,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO/ IWH BOHOL RESORT CORP. offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
