WHEREAS, the PROVINCIAL INFORMATION AND MEDIA OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022-0670 re: Procurement of Ink for High Speed Inkjet Printer with an ABC of P 59,675.00
