BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL INFORMATION AND MEDIA OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. **2022-0670** re: Procurement of Ink for High Speed Inkjet Printer with an ABC of P 59,675.00
