BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE GOVERNOR - PROVINCIAL INFORMATION AND MEDIA OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of the goods under Purchase Request No. **2022-0710** re: Procurement of Spare Parts for Rigo Machine and Photocopier with an ABC of ₱116,230.00;
