BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL LEGAL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-454** re: **PROCUREMENT OF MEALS AND SNACKS FOR THE PLO YEAR-END ASSESSMENT** with an ABC of **P60,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **O.G. HOLDINGS CORPORATION/ THE METROCENTRE HOTEL & CONVENTION CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
