BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1347 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL LEGAL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. 2022-0481 re: Procurement of I.T. EQUIPMENT with an ABC of **P 94,630.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B & J COMPUTER SALES AND ELECTRONIC SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:




