**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022 – 0513** re; **Procurement of Dump Truck Tires** with an ABC of **P492,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTRE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **NORTHWAY TYRE CENTRE** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **NORTHWAY TYRE CENTRE** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
