BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022 – 0660</u> re; <u>Procurement of Tires</u> with an ABC of <u>P 128,770.00</u>;
