**BAC RESOLUTION DECLARING SINGLE COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL**

**WHEREAS**, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

**WHEREAS**, upon the conduct of post qualification by the Technical Working Group, **PRIM E CONSTRUCTION SUPPLIES TRADING**, met the required legal, technical and financial requirements for the said project.

**WHEREAS**, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **PRIM E CONSTRUCTION SUPPLIES TRADING** the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project.

**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
