WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2022 - 171 re: **PROCUREMENT OF VEHICLE SPARE PARTS & TUBELESS TIRES FOR THE MOTOR VEHICLE** with an ABC of **P 75,955.00**.






