## RESOLUTION NO. 22-1820 Series of 2022

BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PRES. CARLOS P. GARCIA MUNICIPAL HOSPITAL</u>, <u>PRES. GARCIA (PITOGO)</u>, <u>BOHOL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2022 - 318</u> re: <u>PROCUREMENT OF SPARE PARTS FOR AMBULANCE AND SERVICE VEHICLE</u> with an ABC of <u>P 153,205.00</u>.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **200 M AUTO REPAIR SHOP & PARTS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **200 M AUTO REPAIR SHOP & PARTS** has been found to be ELIGIBLE and its bid, RESPONSIVE.

THREE THOUSAND NINETY SIX PESOS ONLY (P 153,096.00) for the delivery of goods under Negotiated
