WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1645 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL PROVINCIAL TOURISM** OFFICE in undertaking Procurement Request under PR No. 2022-C-279 re: PROCUREMENT OF CATERING SERVICES DURING THE DISCUSSION OF CURRENT TOURISM ISSUES UNDERMINING THE GROWTH AND SUSTAINABILITY OF THE INDUSTRY with an ABC of P 66,000.00;
