BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **BOHOL PROVINCIAL LIBRARY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-386** re: **PROCUREMENT OF MEALS AND SNACKS FOR THE CAPACITY DEVELOPMENT ACTIVITIES OF THE LGU LIBRARIANS AND LIBRARY EMPLOYEES** with an ABC of **P63,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
