**BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD**

**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-2075 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL ENGINEER'S OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under PR No. 2022-0461 re: Procurement of Passenger Type Vehicle with an ABC of P1,289,600.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ISUZU CEBU - INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:






