BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH COMMUNITY PARTICIPATION, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2022-0763 Te: Procurement of Pasteurized Carabao's/Cow's Milk and Bread Bun for Feeding Program with an ABC of P 4,932,840.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL DAIRY COOPERATIVE offered the single price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
