
WHEREAS, the **TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2021 - 331 re: **PROVISION FOR THE CALIBRATION OF VARIOUS MEDICAL EQUIPMENT IN COMPLIANCE TO ISO 9001: 2015 REQUIREMENTS, NEEDED TO TEST MEDICAL DIAGNOSTIC EQUIPMENT EFFICIENCY** with an ABC of P 300,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **AMI EQUIPMENT SERVICES & SOLUTIONS INC.** in the amount of **TWO HUNDRED NINETY FIVE THOUSAND PESOS ONLY (P 295,000.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2021 - 258**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


