WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0263A series of 2022 re: BA Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL AGRICULTURIST** undertaking Procurement Request under PR No. **2022-0178**, Procurement of Fermented Pure Chicken Manure, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of **₱ 404,800.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **MARCELA FARMS INCORPORATED - AQUA CURLTURE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




