**WHEREAS**, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0588 re; Procurement of Photo Printing of Official Portrait of the Provincial Local Chief Executive, by the Office of the Governor, New Capitol Building, Tagbilaran City, with an ABC of P 135,000.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that RAMASOLA VISUALS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


