WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 - 0234 re; PROVISION FOR THE SUPPLY OF LABOR & MATERIALS FOR ESTABLISHMENT OF WATER SYSTEM AT BALILIHAN PLANT NURSERY with an ABC of P 220,000.00;





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




