**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0841**, re; **Procurement of various SPARE PARTS, OIL AND LUBRICANTS, TIRES, AND BATTERY FOR THE REPAIR, REPLACEMENT OF WORN-OUT PARTS OF MITSUBISHI STRADA SKN - 810, & SKN - 850** with an ABC of **P501,999.50**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **NORTHWAY TYRE CENTRE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


