WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. **22-1880** series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of such Method of Procurement by the **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. **2022-0635** re: **Furnishing of materials for the completion of storage room and fabrication of office tables at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P-145,000.00**;





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:


