BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **BOHOL INVESTMENT PROMOTION CENTER (BOHOL BUSINESS ONE STOP SHOP), OLD CAPITOL BUILDING, TAGBILARAN CITY** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2021 - 0041**; re: **Procurement of HP Floor Standing Inverter Air-Conditioning Unit** with an ABC of **P 120,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SAMMY'S AIRCONDITONING & REFRIGERATION SERVICES & REPAIR SHOP** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **SAMMY'S AIRCONDITONING & REFRIGERATION SERVICES & REPAIR SHOP** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **SAMMY'S AIRCONDITONING & REFRIGERATION SERVICES & REPAIR SHOP** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **SAMMY'S AIRCONDITONING & REFRIGERATION SERVICES & REPAIR SHOP** for the delivery of goods/services under Negotiated Canvass No. **2021 - 0029** in the amount of **P 119,250.00**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
