**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 083 re: PROCUREMENT OF MEDICAL EQUIPMENT with an ABC of P 210,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that RUEN GONZAGA MARKETING & DEVELOPMENT INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare RUEN GONZAGA MARKETING & DEVELOPMENT INC. as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 208,800.00 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2022 - 032;
- b.) To recommend award to RUEN GONZAGA MARKETING & DEVELOPMENT INC. in the amount of **TWO HUNDRED EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (P 208,800.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 032;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




